2019 Legislation PCAV Supported Signed into Law

In the four years the PCAV has been making an annual trip to the General Assembly, the importance of these visitation days has become crystal clear. The relationships built with key legislators and with constant monitoring of important bills during each session, has resulted in recognition of the PCAV as a key stakeholder in matters dealing with transportation, the precast industry and heavy construction reliant on the use of our products. We approached the 2019 visit day with two main talking points when face-to-face with legislators; Coal Ash Bills and I-81 funding. On this page and next, please see the details from the two March press releases from Governor Northam's office as he signed the bills we fought so hard for into law. These are proof positive what we do and the relationships we have built and will continue to build, have a significant and tangible results!

Governor Northam Signs Historic Coal Ash Clean Up Legislation

Newly-approved bills will protect water quality by removing over 27 million cubic yards of coal ash from unlined ponds in Chesapeake Bay Watershed

RICHMOND—Governor Ralph Northam has signed legislation to clean up more than 27 million cubic yards of coal ash from unlined ponds in Virginia, after a historic bipartisan agreement that was supported by Democratic and Republican members of both the House and Senate.

[Senate Bill 1355](#), sponsored by Senator Frank Wagner, and [House Bill 2786](#), sponsored by Delegate Riley Ingram, require the closure and removal of any coal combustion residuals (CCR) units, defined in the bills to include coal ash ponds or landfills, within the Chesapeake Bay watershed. The legislation will clean up four sites in Chesapeake City and the counties of Prince William, Chesterfield, and Fluvanna by moving coal ash to lined landfills on site or recycled in a safe manner.

The bills signed by Governor Northam include the major components of legislation introduced on his behalf by Senator Scott Surovell and Delegate Jennifer Carroll Foy, such as a ban on so-called "cap-in-place" closure of the unlined ponds and a requirement to recycle at least 25 percent of the ash into encapsulated beneficial uses. Concerns about using "cap-in place," an approved, but potentially inadequate closure method led the General Assembly to impose a moratorium on closure the last two years while alternatives were explored.

"The potential risks to public health and water quality posed by unlined coal ash ponds in the Commonwealth are far too great for us to continue with business as usual," said **Governor Northam**. "This historic, bipartisan effort sets a standard for what we can achieve when we work together, across party lines, in the best interest of all Virginians. I am proud to sign this legislation into law."

"Throughout last year we worked hard in a bipartisan manner to develop legislation that you see today to once and for good resolve the issue of coal ash and its permanent disposal," said **Senator Frank Wagner**. "I'm glad to see that all this work has resulted in a permanent solution to Virginia's coal ash issues."

"I was pleased to see that the General Assembly, the Governor, House, Senate and Dominion were able to all come together and come up with a great solution for the coal ash ponds, and in my opinion for the betterment of everyone," said **Delegate Riley Ingram**.

"I am proud of what we have achieved by bringing together the many stakeholders facing serious threats from unlined coal ash ponds," said **Secretary of Natural Resources Matthew J. Strickler**. "Clean closure of these sites will reduce the likelihood of a massive spill that could devastate tributaries to the Chesapeake Bay, and remove the possibility of contaminated groundwater."

"This bipartisan agreement will guarantee the safety of our environment and waterways while responsibly cleaning up the coal ash," said **House Speaker Kirk Cox**. "The most important thing for the Chesterfield community was to minimize truck traffic, and I'm pleased at the strong measures included in this legislation to keep trucks off roads in and around nearby neighborhoods."

"I am pleased that the Governor worked with the environmental community, the industry and key legislators to reach a solution that best addresses the need to keep our air, soil and water safe and protects the residents who live near these coal ash ponds," said **Senator Rosalyn R. Dance**.

"At town halls and meetings with my constituents, I promised that I would fight for legislation to recycle coal ash into concrete and other materials and to excavate and remove the remainder of coal ash to lined landfills because it was the most effective way to protect public health and the environment," said **Delegate Jennifer Carroll Foy**. "I am proud that all of our bipartisan hard work has fulfilled this promise and resulted in comprehensive, impactful legislation to clean up toxic coal ash throughout Virginia."

"I think this represents the first time Virginia has adopted environmental regulations that are more protective of the environment than federal law," said **Senator Scott Surovell**. "This represents an important step forward for environmental protections in Virginia."

"I'm excited that the Governor is signing what I've worked tirelessly on for four years with Senator Surovell; legislation for the people of Virginia, my constituents of Chesterfield, holding Dominion Energy responsible for the coal-ash piles affecting our environment, our

2019 Legislation PCAV Supported Signed into Law

Governor Northam Announces Amendments to Fund \$2 Billion I-81 Improvement Plan

Amendments identify dedicated revenue to make I-81 and all Virginia interstates safer and more reliable

SALEM—Governor Ralph Northam today announced amendments to Senate Bill 1716 and House Bill 2718, legislation passed by the General Assembly providing \$151 million in dedicated funding for the Interstate 81 Corridor Improvement Plan. The amendments would ensure that the \$2 billion program approved by the Commonwealth Transportation Board (CTB) in December 2018 is implemented, while also generating critical revenue for interstates across the Commonwealth.

The amendments create equity in transportation funding by bringing Virginia's truck registration fees, and diesel and road tax rates more in line with those of the other states along the 855-mile I-81 corridor. The funding mechanisms also include a 2.1 percent increase in the regional motor fuels tax along the I-81 corridor, ensuring all users contribute to funding I-81.

These amendments establish dedicated funding for I-81 and Virginia's other interstates, including I-95, I-64, and the Northern Virginia Transportation Authority (NVTA). While \$151 million will be invested in I-81, I-95 will receive \$40 million, I-64 will receive \$28 million, \$20 million will go to the NVTA, and \$43 million is reserved for investment in other interstates as prioritized by the CTB.

"This year I worked closely with Democratic and Republican legislators to reach a long-term agreement that would address the critical safety and reliability issues along the I-81 corridor and make historic investments in the economic competitiveness of this vital region of the Commonwealth," **said Governor Northam**. "We can't wait another year to find a solution—I am pleased to offer amendments that will establish dedicated funding sources to support improvements that will lead to a major reduction in crashes and travel delays."

Senate Bill 1716, introduced by Senators Mark Obenshain and Bill Carrico, and House Bill 2718, introduced by Delegates Steve Landes and Terry Austin, contained a governance structure, an Interstate 81 Corridor Improvement Fund, and toll financing, but the funding was not included in the version of the bill sent to the Governor.

"Interstate 81 is a critical element of Virginia's transportation network," **said Secretary of Transportation Shannon Valentine**. "The urgency surrounding I-81 has created the opportunity to establish dedicated funding for capital and operational investments in I-81 promoting safety, economic growth, and investment for all Virginians."

The 325 miles of Interstate 81 (I-81) that run through western and Southwest Virginia connect five metropolitan areas and 30 institutions of higher learning and serve as a significant corridor for carrying more than \$300 billion in commerce and goods. While both the vehicle miles traveled on I-81 in this region have increased significantly over the years, the corridor has remained largely unchanged and improvements to the interstate underfunded.

"Fixing long-standing issues with I-81 is a top priority to me and my constituents who use this road every day," **said Senator Bill Carrico**. "Finding a funding mechanism to support improvements that will make Interstate 81 safer is our common goal. With almost 50 percent of all Virginia goods being transported on the hundreds of miles of I-81, and 11 million trucks per year traveling this interstate, we need to work towards crucial improvements as soon as possible to make travel safer for the public."

"I'm glad the Governor is initiating a start at fixing I-81 without further delay," **said Senator John S. Edwards**. "The problems with I-81 are more than inconvenient and effect the economy of the entire Commonwealth."

"This is a rare opportunity for the Roanoke and New River Valley regions to get the dedicated funding for Interstate 81 that we deserve," **said Delegate Chris Hurst**. "This plan will also help fund transportation projects around the Commonwealth and should be seen as a major investment in critical infrastructure for everyone's benefit."

"One of my top priorities for the 2019 General Assembly session was to support positive solutions to the dilemma of I-81," **said Delegate Tony Wilt**. "Through further engagement with the Administration and stakeholders, I am pleased to see a bipartisan effort to improve I-81 come before us. My family business is part of the trucking industry. While this funding plan will certainly pose additional costs to our business, there is absolutely a cost to all citizens and businesses along the corridor if we continue to do nothing. This plan is a more equitable approach than some previously considered and will fund improvements that result in more efficient traffic flow and a decrease in the terrible loss of life so many families have had to endure."

A survey by the Virginia Transportation Construction Alliance last December found that area residents were looking for immediate action on the safety and reliability issues along the corridor. This amendment responds to the call for action by legislators, residents of the communities surrounding the I-81 corridor, and businesses to address the needs of I-81 and all of Virginia's interstate highway corridors. The Interstate 81 Corridor Improvement Plan identified top problem areas and prioritized potential solutions based on public input. It

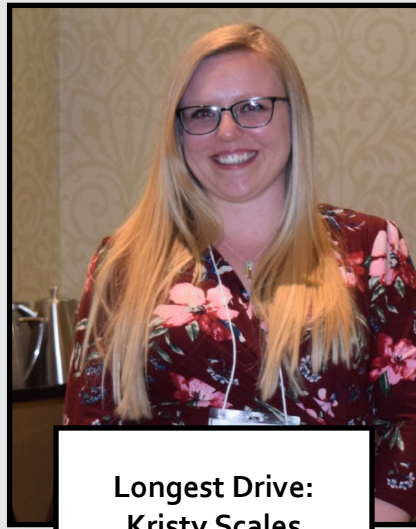

"VDOT Staunton District Bridge Program"



The Staunton District Bridge Section is responsible for 3500 structures: approximately 2200 bridges (45% concrete) and 1300 culverts (85% concrete). Building on a history of innovation and preservation, more than 96% of Staunton District's bridge

inventory is not structurally deficient. His mission is to pursue best practices in support of sustainable bridge infrastructure is crucial.

"Precast Concrete in Winemaking"



In the United States there have predominantly been two vessels for fermenting and aging wine: stainless steel and oak. In recent years, influential wineries have been experimenting with precast concrete tanks. Concrete has

a long history of use in European wineries particularly across France in the Rhone Valley, Burgundy, and Bandol. Those producers in the concrete vanguard feel it occupies a sweet spot between oak and steel by allowing gradual oxygenation of the wine similar to oak but without the oak flavor.

Fly ash is an important recycled supplementary cementitious material (SCM) used in concrete mixtures for several reasons. Not only does it improve the properties of freshly mixed concrete, it provides an important defense against durability problems like reinforcing steel corrosion, sulfate attack, and alkalisilica reactivity (ASR) while diverting an industrial waste to beneficial use. As we burn less and less coal to make electricity, the quantity of fly ash suitable for concrete continues to dwindle in our region. The landmark coal ash legislation passed in the 2019 General Assembly session will affect not only the supply of fly ash, but also the cost of electricity for our homes and businesses as well as our stewardship of a healthy environment.

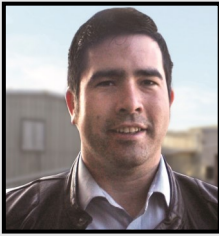

Smith-Midland achieves Gold Status in ABC Safety Award program

Associated Builders and Contractors, Inc. (ABC) awarded Smith-Midland Corporation with the prestigious Gold Level of Achievement Safety Training and Evaluation Process (STEP) Award for 2018. The STEP Awards recognize companies for their meritorious safety performance in a given year. The award winners are determined using safety factor calculations that incorporate data from Occupational Health and Safety Administration (OSHA) reports and require companies to have extensive programs covering personnel training, on-the-job performance, documentation and evaluations.

The STEP awards are based on 20 key elements of a contractor's safety program that includes safety policies, employee commitment and training, management commitment and budgeting.

STEP was established in 1989 by the ABC National Environment, Health & Safety Committee to assist ABC members in evaluating and improving corporate safety practices and to recognize outstanding safety training efforts. Each year, over 2,000 contractors of various sizes participate in the STEP program.

To achieve the Gold Level, Smith-Midland had to meet the following criteria: Minimum Gold Level Standard on 20 Key Components; Incidence rate equal to or below the national BLS average for applicant's NAICS code; and submittal of an OSHA Form 300A for verification.
